1.3.1: The Institution integrates cross-cutting issues relevant to gender, environment and sustainability, human values, health determinants, Right to Health and emerging demographic issues and Professional Ethics into the Curriculum as prescribed by the University / respective regulative councils

Every department within the institution includes courses in its curriculum that include cross-cutting problems. Our curriculum includes instruction on gender equality, including themes such as Parivar Niyojana, Reproductive and Child Health Care, HIV control Programme, MCH, PNDT, and MTP Act.

Our institution promotes the active involvement of students in both sports and cultural activities, including their participation in national and international yoga contests. The institute organizes a range of integrative activities, such as Vanamahotsav, which focuses on tree plantation. Banners promoting the conservation of trees and the environment are prominently displayed across the college campus. Our Educational Programme covers a range of topics including cultivation and conservation of medicinal plants, protection of endangered species, social and environmental health practices, such as waste management and pollution control, as well as disaster management and the Indian factories Act. The college has a National Service Scheme (NSS) section that organizes various events aimed at promoting environmental consciousness.

Incorporating strong moral principles among students is an essential component of our curriculum. Human values are vital for fostering constructive human behavior and activities in our everyday existence. The curriculum has a specific focus on the topics of 'Sadavritta' and 'AacharRasayan', which aim to instill human values in children and help them develop into morally upright individuals. Our Institute organizes a daily yoga session to promote physical and mental well-being.

Professional ethics provide guidelines for individuals' conduct towards others within an organization.

The third year of the Agadtantra department focuses on providing a comprehensive understanding of professional ethics, which includes the attributes, obligations, and duties of a vaidya. The curriculum of Agadtantra and Vyavahar Ayurved includes instruction on various topics such as medical record maintenance, the role of physicians in criminal cases, professional, civil, and criminal negligence, the medico-legal aspects of AIDS, the rights of unborn children, the MTP Act, the Transplantation of Human Organs Bill Act-1994, the International Code of Medical Ethics for Doctors, and the Clinical Establishment and Consumer Protection Act-1986. The highly knowledgeable students organize awareness programs via skits, rallies, and NSS activities on issues such as the rights of unborn children, AIDS, blood donation camps, and the transplantation of human organs. They also motivate and raise awareness among the public about the importance of organ donation. By acquiring practical knowledge, students will adhere to professional ethics and actively engage in their professional pursuits.
